Company is having live enquiries of more than Rs. 4000 Crores as on September 30, 2009.

During the year 2008-09, Rs. 128 Crores have been capitalized as Fixed Assets. In current year 2009-10 there will be addition of fixed assets to the tune of approximately Rs. 65 Crores.

The company has grown by around 16% in Turnover for the year 2008-09 over previous year and expects to achieve Turnover of Rs. 1150 Crores in 2009-10.

The Company has initiated a corporate restructuring exercise with a view to explore various strategic options to consolidate businesses within the group companies; enhancing shareholders' value; synergy realization; and providing financial flexibility for raising further equity and / or debt to fund future growth plans.
